OFFICIAL RULES

OPEN TO RESIDENTS OF THE 50 UNITED STATES (D.C.), 18 YEARS OF AGE AND OLDER ONLY

1. TO ENTER AND PLAY: This promotion ("Promotion") consists of both the instant win game ("Instant Win Game") and the sweepstakes ("Sweepstakes"), begins at 12:00 am ET on November 6, 2017, and ends at 11:59 pm ET on December 31, 2017 ("Promotion Period").
