OPEN TO RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA ("D.C."), 18 YEARS AND OLDER ONLY

This promotion ("Promotion") consists of both the instant win game ("Instant Win Game") and the sweepstakes ("Sweepstakes") described in these Official Rules. Promotion begins at 12:00 am Eastern Time ("ET") on November 1, 2020 and ends at 11:59 pm ET on December 31, 2020 ("Promotion Period"). 1. TO ENTER AND PLAY: During the Promotion Period, visit www.7eleven gaming.com ("Website") and follow the links and instructions to complete and submit the registration form, including providing a valid email address. You will automatically receive one (1) Sweepstakes entry and advance to the Instant Win Game page and one (1) Instant Win Game play. If you receive an Instant Win Game winning message, follow the on-screen instructions to claim your prize. Prizes are subject to verification by Merkle Inc. Winners will be determined through random processes (see Rule 3, below).
