

BELVITA MY BREWMANCE SWEEPSTAKES 2021

OFFICIAL RULES

NO PURCHASE OR SHARE NECESSARY. Making a purchase will not increase your chances of winning.

OPEN TO RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA ("D.C."), AND PUERTO RICO, 18 YEARS AND OLDER ONLY

The Sweepstakes is no way sponsored, endorsed, administered by, or associated with Facebook, Twitter, or Instagram. Facebook, Twitter, and Instagram are not affiliated with Mondelēz Global LLC ("Sponsor") in any way.

1. TO ENTER: The Sweepstakes begins at 12:00 am ET on January 2, 2021 and ends online at 11:59 pm ET on February 15, 2021 (the "Sweepstakes Period"). (See end date for Mail-in entries below.)

To participate using the entry methods outlined in 1.a or 1.b, you must have a Twitter or Instagram account ("Social Account"). Your Social Account settings must be set to "unprotected" and/or "public" for your Tweets or posts to be viewable by Sponsor and its agents. You will receive one (1) entry into the Sweepstakes. **Limit: One (1) Sweepstakes entry, per person/email address/Social Account, during the Sweepstakes Period for this method.**
- c. **Online:** Visit www.belvitaBrewmancesweeps.com ("Website") and follow the links and instructions to complete the registration form. Then, follow the instructions to upload a photo that you have created that "showcases your brew-mance" which includes a belVita product and coffee. You will receive one (1) entry into the Sweepstakes. **Limit: One (1) Sweepstakes entry, per person/email address /Social Account, during the Sweepstakes Period for this method.**

- d. **Mail-in Alternate Method of Entry:** To enter without making a purchase, hand print your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "belVita My Brewmance Sweepstakes 2021," c/o Merkle Inc., P.O. Box 5031, Department 846006, Kalamazoo, MI 49003-5031. You will receive one (1) entry into the Sweepstakes. Limit: One (1) entry per envelope. All mail-in entries must be legibly handwritten and must be postmarked by February 16, 2021 and received by February 23, 2021. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, damaged, unintelligible, illegible, misdirected or postage-due mail-in entries, all of which will be disqualified. **Limit: Three (3) Sweepstakes entries, per person, during the Sweepstakes Period for this method.**

C.)
