# 2024 NABISCO BACK-TO-SCHOOL SNACK & PLAY PROMOTION

#### **OFFICIAL RULES**

#### NO PURCHASE OR SCAN NECESSARY

MAKING A PURCHASE OR SCAN WILL NOT INCREASE YOUR CHANCES OF WINNING.

OPEN TO RESIDENTS OF THE 50 UNITED STATES, DISTRICT OF COLUMBIA ("D.C."), AND PUERTO RICO, 13 YEARS OF AGE AND OLDER ONLY

Click on the link included in the email and follow the links and instructions to revisit the promotion Website, follow the links and instructions to complete and submit the registration form, including your first and last name (initials are not sufficient) and email address. You automatically will receive one (1) Sweepstakes entry. To receive one (1) Instant Win Game play, click/tap on the "Super Snack Stash" Activity "Play Now" button. Follow the links and instructions to play the Activity and your Instant Win Game results will be displayed. You automatically will receive one (1) Sweepstakes entry. To receive one (1) Instant Win Game play click/tap on the "Super Snack Stash" Activity. Follow the links and instructions to play the Activity and your Instant Win Game results will be displayed. Instant Win Game and Sweepstakes winners will be determined through random processes (see Rule 3, below).

- D.) Facebook Referral: Share a message about the Promotion on your Facebook Timeline. The post will contain a unique link to the Sweepstakes.
