

## NABISCO SNACK TO GOLD – AWG

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

#### OPEN TO RESIDENTS OF THE 50 UNITED STATES (D.C.), 18 YEARS OF AGE AND OLDER ONLY

**2. ELIGIBILITY:** Instant Win Game is open to residents of the 50 United States (D.C.), who are 18 years of age and older at the time of entry, except for employees of Mondelez Global, LLC ("Sponsor"), HelloWorld, Inc. You agree that you will not join your claims to those of any other person and that you will not agree to class or collective procedures in arbitration or the joinder of claims in arbitration. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or

the rights and obligations of the entrant, Administrator and Sponsor in connection with the Instant Win Game or any prize, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules.
