

OREO DUNK SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY

OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES (D.C.) AND PUERTO RICO, 18 YEARS AND OLDER ONLY

1. TO ENTER: Sweepstakes begins at 12:00 am ET on January 16, 2017 and ends at 11:59 pm ET on April 30, 2017 (the "Sweepstakes Period"). During the Sweepstakes Period, take a photo or video of you dunking an OREO in milk or, to enter without dunking an OREO in milk, visit a store location and take a photo or video of yourself with an Oreo product package in store. Then, login to your Instagram or Twitter account and post or Tweet your photo or video and include the hashtag #OreoDunkSweepstakes. You will receive one (1) Sweepstakes entry into the drawing for a valid post or Tweet. You may also login to your Facebook account and visit the Sponsor's Facebook page at <https://www.facebook.com/oreo/> and locate the Sweepstakes post. Upload your photo or video as a comment to the Sponsor's post and include the hashtag #OreoDunkSweepstakes. You will receive one (1) Sweepstakes entry drawing for a valid post. Hereafter, a valid post or Tweet will be referred to as your "Submission." Your Submission may include other people. If any individuals other than yourself appear in the Submission, you must have the permission of the individuals (if a minor is in Submission, he/she must be the child or legal ward of the entrant) to use their name and/or photograph/likeness in the Submission. SWEEPSTAKES DRAWINGS: Administrator will randomly select forty thousand (40,000) finalists (each a "Finalist") from all eligible entries received during the Sweepstakes Period on or around May 1, 2017. Sponsor will label and place forty thousand (40,000) cups (one (1) per Finalist) on the ground. A drone will drop five (5) Oreos randomly into five (5) cups. Each Finalist associated with a cup with an Oreo will be deemed a potential Grand Prize winner. If a cup is missed or two (2) Oreos drop into a single cup, the drone will drop Oreos again until five (5) Oreos each land in a cup. Odds of winning a Grand Prize will depend on the number of eligible entries received during the entire Sweepstakes Period. The return of any prize notification as undeliverable may result in disqualification, and the prize may be awarded to an alternate winner. Any prize won by a person who is not at least the age of majority will be awarded in the name of the winner's parent/legal guardian.
