OPEN TO RESIDENTS OF THE 50 UNITED STATES (D.C.), 18 YEARS OF AGE AND OLDER ONLY

1. TO ENTER AND PLAY: Promotion begins at 12:00 am ET on June 5, 2017 and ends at 11:59 pm ET on June 25, 2017 ("Promotion Period"). This promotion ("Promotion") consists of both the instant win game ("Instant Win Game") and the sweepstakes ("Sweepstakes") described in these Official Rules. During the Promotion Period, visit www.oreoinstantwin.com, register (if you have not already), and follow the onscreen instructions to enter. You automatically will receive one (1) entry into the Sweepstakes and advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. If you receive an Instant Win Game winning message, follow the on-screen instructions to claim your prize. Prizes are subject to verification by HelloWorld, Inc.

Limit: There are concurrent OREO Instant Win Game programs.
