

# **MARVEL OREO Save the Stuf Official Rules**

**NO PURCHASE OR QR CODE SCAN NECESSARY. A PURCHASE  
WILL NOT INCREASE YOUR CHANCES OF WINNING.**

## **Eligibility:**

MARVEL OREO Save the Stuf (the “Sweepstakes”) is open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years old at the time of entry (at least 19 years old if you reside in Alabama or Nebraska). To receive the Grand Prize, entrant must be able to submit a valid IRS Form W-9. Employees, officers and directors of Mondelēz Global LLC (“Sponsor”), Merkle Inc. **Timing:**

The Sweepstakes begins on February 2, 2026 at 12:00 a.m. Eastern Time ("ET") and ends on February 18, 2026 at 11:59 p.m. ET (the "Promotion Period"). For purposes of this Promotion, each "Day" begins at 12:00 am ET and ends at 11:59 pm ET. Administrator's servers are the official time-keeping devices for the Sweepstakes.

**Use of a Mobile Device:**

If you choose to register and/or enter using a mobile device, standard message and data rates may apply in accordance with your personal mobile service plan. Check details of your plan prior to using a mobile device to enter. A mobile device is not required to participate.

**How to Register to Participate:**

During the Promotion Period, visit [www.marveloreostufoflegends.com](http://www.marveloreostufoflegends.com) ("Promotion Site") either directly or via a QR code on Sweepstakes-related materials, and follow the links to submit your valid email address. The email address submitted must be:

- Able to receive emails;
- Personal to entrant and under entrant's sole control;
- Private and not publicly accessible; and
- Cannot be a "relay" alias or similar, i.e. one that forwards emails to your inbox, while masking your real email address.

Upon confirmation of your valid email address, you will receive an email with a link to register for the program (first visit only). To register, accurately submit your full first and last name (initials are not sufficient), email address, home mailing address (P.O. Boxes are not permitted), your phone number, and date of birth. For subsequent visits, you will only need to provide your registered email address to log in to the Promotion Site.

**How to Earn Entries:**

There are multiple ways to earn Sweepstakes entries during the Promotion Period.

## **Entry Method 1- Opt-In to Email Marketing OR Send in Mail-In Entry**

### **Opt-In to Email Marketing:**

On the registration form, you will have the option to opt-in to receive marketing emails from Sponsor to receive 1 Sweepstakes entry. You may opt-out of these email communications at any time. All mail-in entries must be sent/postmarked by February 18, 2026 and received by February 25, 2026. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by the Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

### **Entry Limit:**

There is a limit of 1 entry per person using Entry Method 1 for the entire Promotion Period.

## **Entry Method 2 – Play the Save the Stuf Game or “Skip”**

### **Earn Entries by Playing the Game:**

During the Promotion Period, login to the Promotion Site and launch the Save the Stuf Game (“Game”). Follow the in-Game instructions to vote for the “Route” you would like the truck to take the next Day. The Route with the highest number of votes from all participants is the Route the truck will take the next Day. Upon voting for a Route each Day, you will earn the number of entries available for the Day you participate, as set forth in the table below:

Next, place up to 4 “Scanners” along the Route you voted for above. You will receive 1 entry for each Scanner placed, per Day.

**Or, Earn Entries by Skipping the Game:**

To earn entries without playing the Game, click on the “Skip the Experience” button to proceed directly to voting for a Route. Upon placing your vote for a Route, you will automatically be awarded the maximum number of entries available for playing the Game that Day.

**Entry Limits:**

You may only receive up to the number of entries set forth in the table above for the applicable Day for voting for a Route, and up to 4 entries per person per Day for placing Scanners.

**Entry Restrictions:**

Multiple entrants are not permitted to share the same email address. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Sweepstakes. ARV: \$2,000.

**Total ARV:**
