Official Terms & Conditions

NO PURCHASE NECESSARY. Making a purchase will not increase your chances of receiving a Reward (as defined below).

OPEN TO RESIDENTS OF THE 50 UNITED STATES, D.C. AND PUERTO RICO, 18 YEARS OF AGE AND OLDER ONLY

1. HOW TO PARTICIPATE: Program begins at 12:00 a.m. ET on November 1, 2022 and ends at 11:59 p.m. ET on December 31, 2022 or whenever all two thousand (2,000) Rewards (as defined below) are claimed, whichever occurs first (the "Program Period").

P.O. Boxes are not permitted.
