OFFICIAL RULES

NO PURCHASE NECESSARY OPEN TO RESIDENTS OF THE 50 U.S., THE DISTRICT OF COLUMBIA ("D.C."), AND PUERTO RICO, 18 YEARS AND OLDER ONLY

Sweepstakes begins at 12:00 am Eastern Time ("ET") on August 2, 2021, ends at 11:59 pm ET on August 31, 2021 ("Promotion Period") and consists of four (4) weekly entry periods (each a "Weekly Entry Period"), each of which has its own corresponding prize drawing (see details below).
