OFFICIAL RULES

NO PURCHASE NECESSARY. Making a purchase will not increase your chances of winning.

OPEN TO RESIDENTS OF THE 50 UNITED STATES/THE DISTRICT OF COLUMBIA ("D.C."), 18 YEARS OF AGE AND OLDER ONLY

This promotion ("Promotion") is in no way sponsored, endorsed, or administered by, or associated with Facebook, Inc., Instagram, LLC or Twitter, Inc. Facebook, Instagram, and Twitter are not affiliated with the Sponsor in any way.

1. TO PLAY: Promotion begins at 12:00 am ET on June 25, 2022 and ends at 11:59 pm ET on September 6, 2022 ("Promotion Period"). The Promotion consists of an instant win game ("Instant Win Game"), and a collect and win game ("Collect and Win Game"), both of which utilize a single game piece ("Game Piece"), as described below. **There are two (2) ways to obtain a Game Piece:** **A.) Make a Purchase:** During the Promotion Period, visit a Walmart store to purchase a specially marked package of OREO Cookies, CHIPS AHOY! Cookies, RITZ Crackers, BELVITA Breakfast Biscuits or NABISCO Multipacks and locate the Game Piece attached to the product packaging. Purchases from Walmart Marketplace sellers do not qualify. **B.) Mail-In Alternate Method:** Starting June 8, 2022, to receive a Game Piece without making a purchase, send a self-addressed, stamped envelope in an outer mailing envelope with proper postage affixed (legal residents of Vermont may omit postage from self-addressed return envelope) to "Walmart Collect to Win 2022," c/o Merkle Inc., P.O. Box 5083, Department 852152, Kalamazoo, MI 49003-5083. One (1) Game Piece will be mailed to the address indicated on your return envelope within approximately seven (7) business days of receiving the request. You may submit as many requests as you wish; however, Limit: One (1) request per envelope; one (1) Game Piece per request. All mail-in requests must be legibly hand-printed and must be postmarked by September 6, 2022 and received by September 13, 2022. All requests become the exclusive property of Sponsor, and none will be acknowledged or returned except as provided herein. Proof of sending a request will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, damaged, invalid, unintelligible, illegible, misdirected or postage-due Game Piece requests or Game Pieces, all of which will be disqualified.

Open the Game Piece to reveal the scratch-off areas. Scratch the appropriate surface to see if you are a potential winner of a prize in the Instant Win Game and scratch the other surface to reveal three (3) Collect and Win Game Logos (each, a "Logo"). Next, enter the 8-digit alphanumeric Code under the win message on your Game Piece. You will receive a win confirmation email within approximately 48 hours following confirmation of your eligibility. Instant Win Game Prize claims must be received by 11:59 pm ET on October 9, 2022, or prize will be forfeited.
